**Declaration of Conformity to EU ROHS DIRECTIVE 2011/65/EU and  
Commission Delegated Directive (EU) 2015/863 of 31 March 2015 amending  
Annex II to Directive 2011/65/EU**

This document certifies that the Products sold by OHMITE MANUFACTURING CO. with suffix letter "E" at the end of the base of part number (but prior to any special packaging codes such as -TR for tape and reel) are in Compliance with the following Directives:

- Directive 2011/65/EU of the European Parliament and of the Council of 8 June 2011 on the restriction of the use of certain hazardous substances in electrical and electronic equipment (also known as "RoHS Recast"). See table below.
- Commission Delegated Directive (EU) 2015/863 of 31 March 2015 amending Annex II to Directive 2011/65/EU of the European Parliament and of the Council as regards the list of restricted substances which adds 4 phthalates (DEHP, BBP, DBP and DIBP) and becomes effective July 22, 2019.
